Public Comment

Robert Maguire: Mr. Maguire questioned the supervisors about their plan if the dirt and gravel road grant is not approved. He explained that it is his belief that the road needs some additional work, including stone and pipes. He also suggested that in the future when additional work is done, it would be helpful to coordinate with neighboring townships. Mr. Maguire also had several questions regarding the financial report. He stated that providing a list of all monthly receipts and disbursements for each account along with credit card statements and a monthly sewage enforcement report would be more transparent to taxpayers.

- 2026 Budget: The supervisors and treasurer/secretary met on 11/13 and 11/20 to discuss/plan the budget. All supervisors were present and in agreement with draft of the budget. On this date, Supervisor Williamson made a motion to approve the budget, which was seconded by Supervisor Grenell. All three supervisors voted to approve the budget.
- Township Website: Williamson made a motion (seconded by Conti) to use Christopher Miller's business as a local resident who has worked with several local municipalities and is familiar with what is needed. All three voted to use Christopher Miller's website services.
- TR 449 Signs: Williamson reached out to Bradco Supply for signs for tr449. They created two designs for us and the quote includes the cost for 6 signs and posts to hang them. Chairman Conti made a motion to purchase the signs, which was seconded by Chairman Williamson. All three supervisors voted to purchase the signs. Township employee Sam Wible will assist in installing the roadmasters when installing.

New Business

- Election Results: Lonnie and Patricia Maurer agreed to be auditors for the township. We will extend the offer to attend the training being conducted by PSATS. Treasurer will follow up with them.

- Community Yard Sale: Chairman Conti would like to have a neighborhood garage sale. Timing would be in mid-May. More discussion will occur at the organizational meeting.
- TR449 Logging- Eric would like to discuss this at our organizational meeting. Motion made by Williamson and seconded by Conti.
